The Mills County Board of Supervisors met this 3rd day of September, 2013, in the Courthouse in Glenwood with Richard Crouch, Lonnie Mayberry and Ron Kohn present.

A Law Enforcement Center construction meeting was held prior to the Supervisors regularly scheduled meeting. There were 12 members present who included the Board of Supervisors and other key players relating to this project. Mike Emanuel of Mecco-Henne Construction gave updates on the progress of the construction and opened up for questions. The next scheduled meeting is set for October 2, 2013 at 8:00 a.m. at the Engineer's meeting room.

Motion by Mayberry, seconded by Crouch to approve the September 3, 2013 agenda as presented and the August 27, 2013 minutes.

Motion by Crouch seconded by Mayberry to approve the purchase of a Lanier MPC3002 digital printer, color copier and fax machine from Counsel Office of Harlan, Iowa in the amount of \$6,823.00 for the Engineer's office.

The Engineer discussed several projects that Secondary Roads are working on as well as discussing road concerns presented to him by the Board.

Motion by Mayberry seconded by Crouch to approve Resolution 13-27- Abatement of Taxes at Law Enforcement Center Site.

Resolution 13-27

The Mills County Board of Supervisors sitting in session on this 3rd day of September, 2013 upon recommendation from the Treasurer and as per IA Code 445.16 shall abate the taxes, interest and penalties on the following described property and direct the County Treasurer to strike the amount due from the County system: The Mills County Treasurer recommends that the 2013/2014 taxes on property owned by Mills County, Iowa, a tax exempt entity of the County and State and legally described as; Parcel #065010100100000, Lot 2 Except N 300' Glenwood Industrial Tract in Section 13, Township 72, Range 43, Glenwood Corp. City of Glenwood in the amount of **\$1,036.00** be abated. Motion carried on a roll call vote: Mayberry – Aye, Crouch –Aye, Kohn – Aye.

The Board tabled the agenda item of appointing alternates for the Loess Hills Alliance Board until they have an opportunity to talk with prospective members. This item will be put back on the agenda for a formal action at a later date.
